ORDINANCE NO. M- 3/52

AN ORDINANCE annexing to the City of Vancouver certain contiguous and unincorporated land located west of the current city limits between the Columbia River and SR-501, known as the Port of Vancouver annexation; providing for such lands to be zoned as they have been zoned by Clark County, as set forth in V.M.C. 20.03.120; providing that said land shall not be liable for outstanding City bonded indebtedness; providing for an effective date of December 14, 1994.

BE IT ORDAINED BY THE CITY OF VANCOUVER:

Section 1. By Resolution M-2845, adopted August 2, 1993, the City Council determined under R.C.W. 35.13.125 that it would accept petitions to annex to the City certain lands contiguous to the City located west of the current city limits between the Columbia River and SR-501. Thereafter, such petitions were signed by persons owning property in the area proposed for annexation which represented more than 75% of the assessed valuation of such property. The City Council after public hearing on December 27, 1993 accepted such 75% petitions and transmitted the proposed annexation to the Clark County Boundary Review Board under R.C.W. Ch. 36.93.

Section 2. The Boundary Review Board considered the proposed annexation at a duly advertised meeting on August 9, 1994. The Board recommended that affected agencies invoke jurisdiction but no such agency invoked jurisdiction, and thus, returned the matter to the City Council on August 18, 1994 pursuant to R.C.W. Ch. 36.93.100.

Section 3. Pursuant to R.C.W. Ch. 35.13, and as discussed and recommended in SR 254-94, the unincorporated land which is contiguous to the City and located

west of the current city limits between the Columbia River and SR-501, is hereby annexed to the City of Vancouver as of 12:01 a.m. on December 14, 1994. The legal description of such annexing land is set forth on Exhibit "A", attached hereto and incorporated berein.

Section 4. V.M.C. 20.03.120 of the City Zoning Ordinance provides that City Council in an annexation ordinance shall designate the City zoning for the annexing land so as to correspond as closely as reasonably can be done to the County zoning of such land (absent a different direction from the City Planning Commission). Accordingly, the Vancouver Comprehensive Plan as amended is applied to cover such land as there provided. All lands which have been zoned MH are hereby zoned MH. All lands which have been zoned MP are hereby zoned ML.

Section 5. The zoning providing for in Section 4 is hereby applied to the land being annexed, as shown on the map attached hereto as Exhibit "B".

Section 6. As to environmental review under R.C.W. Ch. 43.21C, City Council hereby finds that all environmental issues have been properly addressed by the issuance of a Final Environmental Impact Statement.

Section 7. As provided in Resolution M-2845 the land herein annexed shall not be liable for City bonded indebtedness which is outstanding as of the effective date of this Ordinance.

Section 8. This Ordinance shall go into effect at 12:01 a.m. on December 14,

1994.
