# ORDINANCE NO. M-3099

AN ORDINANCE annexing to the City of Vancouver certain contiguous and unincorporated land generally bounded by the current City limits to the north, south, and west, and by the eastern edge of the right-of-way of St. Johns Road to the east; providing for such lands to be zoned as they have been zoned by Clark County as set forth in V.M.C. 20.03.120; providing that said land shall not be liable for outstanding City bonded indebtedness; providing for an effective date of February 1, 1994.

#### BE IT ORDAINED BY THE CITY OF VANCOUVER:

Section 1. By Resolution M-2795, adopted September 8, 1992, the City Council determined under R.C.W. 35.13.125 that it would accept petitions to annex to the City certain lands contiguous to the City and generally bounded by the current City limits to the north, south, and west, and by the eastern edge of the right-of-way of St. Johns Road to the east. Thereafter, such petitions were signed by persons owning property in the area proposed for annexation which represented more than 75% of the assessed valuation of such property. The City Council after public hearing on November 1, 1993 accepted such 75% petitions and transmitted the proposed annexation to the Clark County Boundary Review Board under R.C.W. Ch. 36.93.

Section 2. The Boundary Review Board considered the proposed annexation at a duly advertised meeting on December 14,

The Board took no issue with the annexation and did not recommend that any affected agency invoke jurisdiction and no such agency invoked jurisdiction, and thus the matter returned to the City Council on January 7, 1994 pursuant to R.C.W. Ch. 36.93.100.

Section 3. Pursuant to R.C.W. Ch. 35.13, and as discussed and recommended in SR 40-94, the unincorporated land which is contiguous to the City and generally bounded by the current City limits to the north, south, and west, and by the eastern edge of the right-of-way of St. Johns Road to the east, is hereby annexed to the City of Vancouver as of 12:01 a.m. on February 1, 1994. The legal description of such annexing land is set forth on Exhibit "A", attached hereto and incorporated herein.

Ordinance provides that City Council in an annexation ordinance shall designate the City zoning for the annexing land so as to correspond as closely as reasonably can be done to the County zoning of such land (absent a different direction from the City Planning Commission). Accordingly, the Vancouver Comprehensive Plan as amended is applied to cover such land as there provided. All land which has been zoned R1-6 is hereby zoned R1-6. All land which has been zoned R4 is hereby zoned R2. All land which has been zoned CL is hereby zoned CC. All land which has been zoned CL is hereby zoned CC. All land which has been zoned CH is hereby zoned.

Section 5. The zoning providing for in Section 4 is hereby applied to the land being annexed, as shown on the map attached hereto as Exhibit "B".

As to environmental review under R.C.W. Section 6. Ch. 43.21C, the proposed annexation was the subject of an environmental assessment, and a declaration of non-significance was issued on November 18, 1993. City Council hereby finds that all environmental issues have been properly addressed.

Section 7. As provided in Resolution M-2795 the land herein annexed shall not be liable for City bonded indebtedness which is outstanding as of the effective date of this Ordinance.

Section 8. This Ordinance shall go into effect at 12:01 a.m. on February 1, 1994.




of Vancouver Leverich Park tract; thence East 330 feet along the North line of said tract and continuing along the existing City Limits line as described in City of Vancouver Ordinance Number M-154, dated August 13, 1954; thence South 390 feet more or less along the East line of said tract; thence East 180 feet more or less along the North line of said tract; thence South 110.27 feet along the East line of said tract; thence southeasterly 215.63 feet to a point on the East line of Lot 2, Garden Grove Homestead Lots, Book A of Plats, Page 12, records of said county; thence southeasterly 333.5 feet along the North line of Segregation 2, Lot 9 and Segregation 2, Lot 10, Ampere Acres, Book D of Plats, Page 100, records of said county to the East line of Lot 3 of said Garden Grove Homestead Lots plat; thence South 633 feet more or less along said East line to a point that is 220 feet North of the North line of said Section 23 and the centerline of Northeast Thirty-Ninth Street; thence West 90 feet more or less along a line that lies 220 feet northerly and parallel with said section line to the Northeast corner of the annexation area described under said Ordinance M-798; thence South to the true point of beginning.
