WHEREAS, said hearing has been held as prescribed by law and it appearing that said petition for annexation should be allowed; and

WHEREAS, Resolution in accordance with RCW 35-130 et. seq. and the laws of the State of Washington has been duly adopted by the Mayor of the Town of Battle Ground, Chairman of the Board of County Commissioners of Clark County, and Clark County Superintendent of Schools.
