ORDINANCE NO. 07-010

AN ORDINANCE REGARDING THE ANNEXATION OF UNINCORPORATED TERRITORY TO THE CITY OF BATTLE GROUND, WASHINGTON, AND FIXING ITS ZONE FOR LAND USE.

WHEREAS, On July 11, 2006 the City of Battle Ground received and accepted the initial Notice of Intent to annex approximately 417 acres located south of City along SR 503, known as the South 503 Annexation; and,

WHEREAS, on August 7, 2006, the City Council accepted the notice of intent to annex, expanded the geographical area to include a total of 434 acres, specified that the adopted preannexation zoning would apply to the property upon annexation and that the property proposed to be annexed would be subject to any outstanding indebtedness; and,

WHEREAS, staff obtained signatures on annexation petitions reflecting these conditions. The petition was transmitted on December 22, 2006 to the Clark County assessor to determine its sufficiency. On March 23, 2007 the city received a response from the assessor indicating the petition contained valid signatures representing more than the required 60% of the total assessed value; and,

WHEREAS, on April 16, 2007, the City Council held a public hearing on the annexation proposal pursuant to RCW 35A.14.231; and,

WHEREAS, The City Council recognizes the limited sewer treatment plant capacity available to the City and desires to limit connections in newly annexed areas to insure that properties within the present city limits are able to utilize the limited capacity; and

WHEREAS, The City Council finds that the proposed annexation is consistent with the Comprehensive Plan and will allow for future orderly growth;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BATTLE GROUND, WASHINGTON, DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The property, as set forth in Exhibit "A" and for which the petition for annexation is filed, shall be and is hereby made a part of the City Of Battle Ground and annexed thereto.

Section 2. Pursuant to the terms of the annexation petition, all property within this territory to be annexed hereby shall be assessed and taxed at the same rate and on the same basis as the property within the City of Battle Ground, including assessments or taxes or taxes in payment of any bond issued or debts contracted by order existing at the time of annexation.

- Section 3. In accordance with RCW 35A.14.330, the annexation area shall be subject to the zoning classifications established by the City of Battle Ground Zoning Map adopted by Ordinance No. 04-024.
- Section 4. Lands annexed by this ordinance that are within the City's sanitary sewer service boundary and are zoned for residential use shall not be considered to have adequate sewage treatment capacity to support development prior to the completion of additional sewage treatment capacity at the Clark County Salmon Creek Wastewater Treatment Plant or upon a determination by the City Council that capacity is available.
- Section 5. The City recognizes and will collect fees required under the Clark County Assessment Reimbursement Area 2000-03 recorded under Clark County Auditors File No. 3288459.
- Section 6. Building permits and complete applications for building permits filed with Clark County prior to the date of this ordinance shall be completed up to and including occupancy by Clark County.
- Section 7. The City Clerk is hereby directed to file with the Board of County Commissioners of Clark County a certified copy of this ordinance. The City Clerk is further directed to file with the Office of Financial Management a certificate as required by RCW 35A.14.700 within thirty (30) days of the effective date of annexation.

Section 8. This Ordinance shall become effective 30 days from the date of adoption.
